TERMS AND CONDITIONS

The Terms and Conditions listed below will be sent to you prior to your booking along with a formal invoice, the Terms and Conditions must be adhered to or service may not be provided.

BRIDAL BOOKINGS

Deposits.

Your Bridal deposit will act as your booking confirmation as well as your consultation cost. This is necessary to secure your booking and must be paid 48 hours after you have received your formal invoice.

For members of the bridal party, a £20 per person deposit is required 30 days prior to the wedding date.

All deposits are non-refundable and non-transferable against the total cost of the service

All payments will be made via PayPal or bank transfer.

Payment of deposit will act as contractual consent to fulfil full payment.

Full payment.

The remaining cost of your booking (excluding deposits) must be paid 7 days prior to the wedding via PayPal or bank transfer, failure to provide payment will result in an additional £10 per day cost for every day that payment is not fulfilled. If payment still has not been fulfilled on the wedding date service will not be provided unless agreed otherwise.

Cancellation policy.

Bookings cancelled up to six weeks prior to the date will incur 50% of the remaining balance for all services. Bookings cancelled up to four weeks prior will incur the full remaining balance to be paid due to the date being secured.

Once a deposit has been paid the client is responsible for any cancellations and their costs. Cancellations also include decreasing the amount of people on a booking after the deposit has been paid.

Travel.

If your booking requires the artist to travel outside of a 10 mile radius of artist home (BN1) then travel costs will be charged, this may include train and bus tickets as well as taxi fares or if travelling by car a £0.45p per mile charge to and from the venue, this also includes any trials.

EVENTS BOOKINGS

Deposits and full payment.

A sum of £10 per person is payable upon booking to secure your booking date via PayPal. The remaining amount is to be paid via PayPal 1 day prior to the event date or in cash on the day.

Once the deposit is paid it is non-refundable and non-transferable against the total cost of your booking. If you wish to reschedule your booking you may transfer your deposit to another booking provided I am notified 7 days before the date of the booking and I am available on the new desired date.

Please note that if you wish to pay in cash on the day and are unable to fulfil payment a £10 per day charge will incur every day until payment is fulfilled

For group bookings full payment is to be fulfilled 7 days before the booking via PayPal.

Cancellation Policy.

Deposits for bookings are non-refundable.

Once a deposit has been paid the client is responsible for any cancellations.

Group bookings cancelled ten days prior to the booking date will incur 50% of the remaining amount; bookings cancelled less than ten days prior will be required to pay the full remaining amount of the booking.

Cancellations also include decreasing the amount of people on the booking.

Travel.

If your booking requires the artist to travel outside of a 10 mile radius of artist home (BN1) then travel costs will be charged, this may include train and bus tickets as well as taxi fares or if travelling by car a £0.45p per mile charge to and from the venue, this also includes any trials.

CORPORATE BOOKINGS

Deposits and full payment

For corporate bookings a bespoke day/hourly rate will be quoted dependant on the service required and the length of the booking. A 25% deposit will be paid upon booking to secure your booking date via PayPal or bank transfer.

The remaining amount must be fulfilled 10 days before your booking date via PayPal or bank transfer.

Payment of deposit will act as contractual consent to fulfil full payment.

Cancellation policy.

Deposits for bookings are non-refundable and non-transferable against the full cost of your booking.

Once a deposit has been paid the client is responsible for any cancellations.

Group bookings cancelled ten days prior to the booking date will incur 50% of the remaining amount; bookings cancelled less than ten days prior will be required to pay the full remaining amount of the booking.

Travel.

If your booking requires the artist to travel outside of a 10 mile radius of artist home (BN1) then travel costs will be charged, this may include train and bus tickets as well as taxi fares or if travelling by car a £0.45p per mile charge to and from the venue, this also includes any trials.
